This is to inform you that on the basis of the Inspection Report and recommendations of the Affiliation Committee, the Hon'ble Vice-Chancellor has been pleased to grant fresh affiliation to your College for starting **B.Ed. Two Year Course (with 50 Seats) (01 unit)** duly allotted through the P.T.E.T. as per N.C.T.E. norms for the Session **2018-2019.**, subject to fulfillment of the conditions as mentioned below:-

- 1. "To follow and observe the University Act, Statutes, Ordinances, Regulations, Rules and Instructions framed, amended, adopted and issued from time to time in General and specifically relating to:
 - (a) Admissions of students in the above course.
 - (b) To follow curricula/Courses of study as prescribed by the University from time to time including scheme of examinations and conduct of examinations.
 - (c) Appointment of Teaching/Sports/PTI/Library Staff."
- 2. (i) All the conditions as prescribed by the State Govt. in the N.O.C. No. F.24(889) NOC18-19/बी०एड / आकाशि / 18 / 216 दिनांक 30.03.2018 and NCTE letter No. NRC/NCTE/NRCAPP-2016-16364(ID No. 10717)279th (Part-1) Meeting 2018/ 187551-56 dated 19-01- 2018 will have to be followed and compliance report of fulfillment of all conditions will be submitted within three months.
 - (ii) Staff: Appointment of permanent and qualified Principal and teaching staff on the fulltime basis selected by a duly constituted Committee as per the norms of NCTE/State Govt./UGC before the commencement of the session.
 - (iii) That the reserve fund for an amount equal to three months salary of the Teachers and Staff be created within one month from the date of issue of this order and maintained in the form of FDR in favor of the management/institution, for a period of not less than sixty months (Five Years) in a Nationalized Bank.
 - NCTE/University provisions, play grounds and hostel building.
 - (v) Library: Year wise development of college Library and provision of funds for journals and magazines be made.
 - (vi) Faculty Members: At least two faculty members in each faculty be appointed as per the decision of the Academic Council and Board of Management already circulated to the Principals of all the affiliated Colleges of the University.
 - (vii) To make compliance and fulfillment of the conditions lay down in your affiliation letter and submit it within two months from the date of issue of this letter.
- 3. To provide the information as asked for by the University from time to time including Statistics etc.
- 4. To follow strictly rules and regulations and amendments governed by the UGC/University/ NCTE from time to time.

 - 2. महाविद्यालय में सत्र 2018—19 में 02 वर्षीय बी.एड. पाठ्यक्रम हेतु एनसीटीई के निर्धारित मानवण्डानुसार प्रशासनिक एवं वृतिक स्टॉफ यथा पुस्तकालयाध्यक्ष, प्रयोगशाला सहायक, डाटा एन्ट्री ऑपरेटर नियुक्त नहीं किए है। नियुक्त करना सनिश्चित करें।
