Building: Construction of sufficient building as per guidelines of the (iv) NCTE/University provisions, play grounds and hostel building.

Library: Year wise development of college Library and provision of funds for (v) journals and magazines be made. (vi)

Faculty Members: At least two faculty members in each faculty be appointed as per the decision of the Academic Council and Board of Management already circulated to the Principals of all the affiliated Colleges of the University.
