- Brilwa (a) Admissions of students in the above course.
  - To follow curricula/Courses of study as prescribed by the University from time to time including scheme of examinations and conduct of examinations.
  - Appointment of Teaching/Sports/PTI/Library Staff." (c)

  - That the reserve fund for an amount equal to three months salary of the (iii) Teachers and Staff be created within one month from the date of issue of this order and maintained in the form of FDR in favor of the management/institution, for a period of not less than sixty months (Five Years) in a Nationalized Bank. 12824 ...
  - Building: Construction of sufficient building as per guidelines of the (iv) NCTE/University provisions, play grounds and hostel building.
  - Library: Year wise development of college Library and provision of funds for (v) journals and magazines be made.
  - Faculty Members: At least two faculty members in each faculty be appointed as (vi) per the decision of the Academic Council and Board of Management already circulated to the Principals of all the affiliated Colleges of the University.
  - To make compliance and fulfillment of the conditions lay down in your affiliation (vii) letter and submit it within two months from the date of issue of this letter.
- To provide the information as asked for by the University from time to time including 3.
- To follow strictly rules and regulations and amendments governed by the · UGC/University/ NCTE from time to time. 5.
