- No affiliated institution shall be allowed to discontinue the study of any Subject/Faculty without 10. prior permission of the University. An application for such permission shall be made to the Registrar by the Head of the institution duly forwarded by the Management at least one full academic year in advance, giving reasons in support of the proposal.
- Every college not maintained by the Government shall satisfy the Board that adequate financial 11. provision is available for its efficient maintenance.
