Subject :- Grant of Fresh Provisional Affiliation in B.A. and B.Sc. for the session 2020-2021.

Dear Sir,

With reference to your application for the purpose mentioned in the subject cited above, in this connection I am directed to inform you that on the basis of inspection report and recommendations of the affiliation committee, the Hon'ble Vice-Chancellor has been pleased to grant Fresh Provisional Affiliation in **B.A. (160 seats) Drawing & Painting, English Lit., Hindi Lit., History, Urdu, Political Science, Public Adm., Sanskrit, Sociology, Geography, Maths and Compulsory subjects and B.Sc. (140 seats) Physics, Chemistry, Zoology, Botany & Maths with Compulsory subjects** for the session 2020-2021 to your college subject to fulfillment of the following conditions:

1. No admissions beyond the number of seats allotted by the University will be made. Admissions of the only eligible students will be made. In case admissions over and above the number of seats allotted and admissions of the ineligible students are made, the University will not conduct the examination of such students and the entire responsibility for the same will lie with the college authorities. This should be adhered to strictly. Non-compliance will lead to strict action against the college, which may include disaffiliation.
2. The College will follow and observe the University Act, Statutes, Ordinances, Regulations, Rules and Instructions framed and amended adopted and issued by the University from time to time.
3. The College will follow curricula Courses of Study as prescribed by the University from time to time, which will include Scheme of Examinations and conduct of examinations.
4. The college will appoint Permanent and qualified Principal and teaching staff, sports staff, PTI etc. on full time basis selected by duly constituted Selection Committee as per University Act and norms of U.G.C. and get the same approved from the University.
5. Building-Construction of building as per the guidelines of the University with provisions of play ground and hostel building.
6. Library- Year wise purchases of books for Library and sufficient provisions will be made for purchase of journals, magazines.
7. Endowment Fund: Endowment fund as provided in the University rules will be created and University will be informed accordingly. Compliance of this point may be reported within one year of issue of affiliation letter.
8. At least two faculty members in each subject will be appointed as per the decision of the Academic Council and Board of Management, which has already been circulated to Principals of all the affiliated colleges of the University.
9. To provide the information as asked for by the University from time to time including Statistics etc.
10. (a) Number of admissions will be restricted to the number of seats allotted by the University. No admission over and above the number of seats allotted will be made.
(b) No admission may be given in the subject (s)/course(s) without obtaining the affiliation in the subject (s)/course(s) concerned.
Non-compliance will entail severe action against the college as per the letter No.31170-313 dated 23-02-2006 and responsibility for the same will be with the college administration.
11. No affiliated institution shall be allowed to discontinue the study of any Subject/Faculty without prior permission of the University. An application for such permission shall be made to the Registrar by the Head of the institution duly forwarded by the Management at least one full academic year in advance, giving reasons in support of the proposal.
12. Every college not maintained by the Government shall satisfy the Board that adequate financial provision is available for its efficient maintenance. If at any time the governing body of a College be unable to run the College, it shall inform the Board at least one full academic year in advance and shall give a notice of similar duration, viz., one full academic year to the employees of the institution for termination of their services: Provided that the closure of an Institution shall be in gradual stages in respect of each course of study for which it is affiliated, starting from the first year of the course.


13. महाविद्यालय नवीन अस्थायी सम्बद्धता हेतु जारी पत्र की दिनांक से दो माह में बिन्दुवार अनुपालना रिपोर्ट विश्वविद्यालय को भिजवाया जाना सुनिश्चित करें।

- I. महाविद्यालय द्वारा सत्र 2020-21 में डॉ० कमलेश कुमार चित्तौड़ा, पी०एच०डी० उपाधि धारक को प्राचार्य नियुक्त दर्शाया गया है। पी०एच०डी० 2014 में होने के कारण 08 वर्ष का शैक्षणिक अनुभव होने के आधार पर निर्धारित योग्यताधारी नहीं है।
- II. महाविद्यालय द्वारा बी०ए० पाठ्यक्रम में गणित विषय हेतु पृथक से शिक्षक नियुक्त नहीं दर्शाया गया है। बी०एससी० पाठ्यक्रम में गणित विषय के दो शिक्षक नियुक्त दर्शाये गये हैं। शिक्षक की नियुक्ति किया जाना सुनिश्चित करें।
- III. महाविद्यालय सत्र 2020-21 में उपरोक्त पाठ्यक्रमों की नवीन अस्थायी सम्बद्धता हेतु जारी पत्र की दिनांक से एक वर्ष में अक्षय निधि कोष हेतु नियमानुसार संस्था सचिव एवं कुलसचिव, मदस विश्वविद्यालय, अजमेर के संयुक्त हस्ताक्षरयुक्त राशि रु. 5.00 लाख की एफडीआर बनवाकर सत्यापित प्रति विश्वविद्यालय को भिजवाया जाना सुनिश्चित करें।
- IV. महाविद्यालय द्वारा विश्वविद्यालय अध्यादेश 70-ए के प्राधानानुसार रु. 100/- के स्टाम्प पेपर पर महाविद्यालय संस्था/ट्रस्ट का बॉण्ड विश्वविद्यालय को प्रेषित नहीं किया गया है।
- V. महाविद्यालय राज्य सरकार द्वारा जारी अनापत्ति प्रमाण पत्र आदेश क्रमांक: क्रमांक 912 दिनांक 25.09.2020 के द्वारा सत्र 2020-2021 से 2022-2023 तक के क्रम में महाविद्यालय को तीन सत्रों की समाप्ति तक स्वयं के भूमि एवं भवन में महाविद्यालय का निर्माण करना होगा।
- VI. महाविद्यालय द्वारा सत्र 2020-21 में श्रीमती प्रीति सैन, एम०लिब० पुस्तकालयाध्यक्ष एवं श्री अनुराग मिश्रा, एम०पीएड को शारीरिक शिक्षक के रूप में नियुक्त दर्शाया गया है। यू०जी०सी० के नवीनतम मानदण्डानुसार योग्यताधारी की नियुक्ति अनिवार्य है।
- VII. महाविद्यालय द्वारा उक्त पाठ्यक्रमों हेतु प्रति विषय 2 जर्नल्स क्रय सम्बन्धी एवं अनु. जाति/अनु.जनजाति छात्रों हेतु बुक बैंक की सुविधा बाबत कोई सूचना प्रेषित नहीं की गई है।
- VIII. महाविद्यालय उक्त पाठ्यक्रमों में प्रवेशित विद्यार्थियों की यूजीसी के नियमानुसार कालांश व उपस्थिति की अनिवार्यता सुनिश्चित करें।
- IX. विश्वविद्यालय पत्र क्रमांक 23894 दिनांक 12.11.2021 की पालना सुनिश्चित करें।

विशेष नोट:- आदेशानुसार महाविद्यालय को निर्देशित किया जाता है कि महाविद्यालय उक्त कमियों की 60 दिवस में पूर्ति कर विश्वविद्यालय को सूचित करें। अन्यथा कमीपूर्ति के अभाव में महाविद्यालय में प्रवेशित विद्यार्थियों को परीक्षा में बैठने की अनुमति प्रदान नहीं की जायेगी।

It may be noted that the application for extension in provisional affiliation/fresh/permanent affiliation for the session 2021-2022 along with the necessary fee as prescribed may be sent through proper channel (**failing which the application form shall be treated as cancelled or otherwise in the case of part submission of the necessary fee the part payment so made shall be forfeited and the said application form shall be rejected**) together with a report about the fulfillment of the conditions of the affiliation up to 31st December, 2020. If already deposited, need not to deposit.
