#### INTRODUCTION

The NEP-2020 offers an opportunity to affect a paradigm shift from a teacher-centric to a student-centric higher education system in India. It is based on Outcome based Education, where the Graduate Attributes are first kept in mind to reverse-design the Programmes, Courses and Supplementary activities to attain the graduate attributes and learning outcomes. The learning outcomes-based curriculum framework for a degree in B.A. Political Science 3-year programme and B.A. Honour's in Political Science with research 4-year programme is intended to provide a comprehensive foundation to the subject and to help students develop the ability to successfully continue with further studies and research in the subject while they are equipped with required skills at various stages. The framework is designed to equip students with valuable cognitive abilities and skills so that they are successful in meeting diverse needs of professional careers in a developing and knowledge-based society. The curriculum framework takes into account the need to maintain globally competitive standards of achievement in terms of the knowledge and skills in Political Science.

The ever-expanding boundaries of Political Science necessitates the understanding of the various aspects of human life. The challenges of Globalization make it imperative for the Political Science discipline to go beyond the regional, national and even international frontiers of knowledge. The curriculum aims to equip the students to understand Political processes properly and evaluate the significance of Political Changes that take place within a society or culture, examine the patterns of such transitions and also assess the patterns of continuity. It would be an endeavour in promoting critical thinking, research and analysis. The course provides an understanding of Political Concepts, Perspectives and Methodology.

Students pursing B.A. (Honours) Political Science will be encouraged to be a part of interactive sessions, discussions and debates. The curriculum would make the young minds more receptive, as well as inquisitive with a scientific bent of mind.

Critical thinking, analytical interpretation and drawing conclusions from data will be the focus of the learning outcomes.

#### PROGRAMME OUTCOMES

The BA (Honours) Political Science Programme covers a comprehensive set of courses ranging from the study of political theories, thoughts, institutions and functions – international, national and local.

The following points are the expected outcomes of the Four Year BA (Honours Programme:

- 1. Through the study of important philosophical, theoretical and ideological foundations in the study of political science, students are expected to develop critical thinking and arguments.
- 2. Study of political systems around the world will not only give knowledge but will also train students towards comparative approaches and methods.
- 3. Students will have an understanding on the international political system as it is and as it ought to be.
- 4. Learning the fundamentals of Indian government and politics is important for Indian students and has a job-prospect particularly in civil services and other competitive examinations.
- 5. By studying organizational and administrative behavior in public administration, students are expected to acquire leadership and management skills.
- 6. The study of human rights will empower students to stand for the protection and promotion of basic human rights and thus contribute to national and international peace.

- 8. In studying government and politics of the Rajasthan students will not only gain knowledge of the State but it will also help students to identify research gaps and research priorities on Rajasthan politics for their higher studies.

## FOUR YEAR U.G. PROGRAMME WITH EXIT POINTS FOR THE STUDENTS

**U.G. Certificate**: Students who opt to exit after completion of the first year and have secured 40 credits will be awarded a U.G. Certificate if in addition, they complete one Vocational course of 4 credits during the summer vacation of the first year. These students are allowed to re-enter the degree programme within three years and complete the degree programme within the stipulated maximum period of seven years.

**U.G. Diploma**: Students who opt to exit after completion of the second year and have secured 80 credits will be awarded the U.G. Diploma if, in addition, they completed one vocational course of 4 credits during the summer vacation of the second year. These students are allowed to re-enter within a period of three years and complete the degree programme within the maximum period of seven years.

**3-year U.G. Degree**: Students who wish to undergo a 3 year U.G. Programme will be awarded U.G. Degree in the Major discipline after successful completion of three years, securing 120 credits and satisfying the Minimum-credit requirements.

**4-year U.G. Degree (Honours) :** A four year U.G. Honours-degree in the major discipline will be awarded to those who complete a four year degree with 160 credits and have satisfied the credit requirement.

**4-year U.G. Degree (Honours with Research) :** Student who secure 75% marks and above in the first six semesters and wish to undertake research in the undergraduate level can choose a research stream in the fourth year. They should do a research project or dissertation under the guidance of a faculty member of University / College. The research project/ dissertation will be in the major discipline. The students who secure 160 credits, including 12 credits from a research project/ dissertation, are awarded U.G. Degree (Honours with Research).

### **Scheme of Examination**

Scheme of examination for end of semester examination applicable to all undergraduate courses (Honours Course).

The question paper of semester Examination for the Disciplinary Specific Core (DSC), Discipline Specific Elective (DSE) and Skill Enhancement Course (SEC) will be of 70 marks and it will be divided in two parts i.e. Part-A and Part-B. Part-A will consist of 10 compulsory questions. There will be at least three questions from each unit and answer to each question shall be limited upto 50 words. Each question will carry two marks. Total 20 Marks.

Part-B will consist of 10 questions. At least three questions from each unit be set and student will have to answer five question, selecting at least one question from each unit. The answer to each question shall be limited to 400 words. Each question carries 10 Marks. Total 50 Marks.
